# **Superintendent's Column**

# Modern learning for a changed world

As the weeks of August turn into early September, our collective attention at home and here at the Hamburg Schools turns towards the dawn of another school year. It is your children who bring the joy to our work and we look forward to welcoming our students back to school on Wednesday, Sept. 4.

I have used this space in the past to talk about the imperative of Modern Learning for all students. I'd like to take this opportunity to talk more specifically about the benefits that modern learning will have on each student, and it is important to begin by stating a couple of the realities that our students will face after they've graduated from High School.

1. Our students will have many different jobs in their lives, most of which don't exist yet

2. The requirements placed upon the modern work force and the typical post-secondary learning environment highlight the need for skills and dispositions not traditionally taught or assessed in schools

3. The world is increasingly characterized by volatility, uncertainty, complexity and ambiguity

With this in mind, our educators will continue to employ research-based tools and strategies that empower our students for their future by requiring them to:

- Be creative and critical thinkers
- Be productive collaborators
- Be effective communicators

For example, students will be more likely to be confronted in class with authentic and complex problem solving opportunities, designed to invite them to work through uncertainty

For their part, students will become used to the idea that pushing through frustration and learning from their mistakes in their pursuit of solutions is as highly valued as an "A" on a traditional test.

and confusion. For their part, students will become used to the idea that pushing through frustration and learning from their mistakes in their pursuit of solutions is as highly valued as an "A" on a traditional test. Also, classrooms are starting to look different. Desks are already less likely to be arranged in rows, and, in fact, students are less likely to even be seated at a traditional desk at all. Student choice and student voice, along with more authentic and performance-based assessments, have become prominent features in classrooms from PreK-12.

There is a Chinese proverb which says that society should "not confine your children to your own

learning, for they were born in a different time." The core of the Hamburg Central School District's commitment to educating your child to become a "modern thinker who creates, cares, solves and discovers" (HCSD Vision Statement) is formed by purposefully designed instruction, which includes:

• Student Agency — students making meaningful choices about their learning. As a result they are collaborating, creating, making and publishing in authentic ways.

- Self-efficacy students experience failure as an opportunity to learn through more information, time and resources
- An emphasis on strong relationships students have productive, enduring and engaging relationships with their peers and their teachers

2019-2020 marks the third year of our modern learning initiative. Over the course of this time, our focus on instructional strategies that support deep and transferable learning have also yielded outstanding scores on Regents and Advanced Placement exams, as well as on the 3-8 NYS Assessments. Additionally, our students continue to be well equipped to follow the post-secondary option of their choice.

# New Middle School Principal aims to energize learning

## *Creative, caring classrooms are key for Thomas Adams*

Bringing a deep knowledge of the middle level learner, Thomas Adams became Hamburg Middle School's new Principal in July.

Mr. Adams' career in education spans 23 years. Most recently, he served as Principal at Newfane Middle School since 2007. Prior to that he was Assistant Principal at the school after starting his career there as a 7th and 8th grade social studies teacher.

In his new position, Mr. Adams will serve as the educational leader of about 800 students in Grades 6-8 and 140 staff members. He will work in partnership with Assistant Principal Amanda Bolin.

"We are fortunate that Tom Adams has joined our team," said Superintendent Michael Cornell. "He comes to us with an outstanding reputation as a teacher and a leader, and was beloved in his former district. Tom is a true expert in middle level education. He is

exactly the right person to press ahead with the great work that's

been done at Hamburg Middle School."

For Mr. Adams, the path to educating modern thinkers begins with classrooms that are creative and caring places, where relevant content is offered in an energizing way to learners.

"It means that classrooms are places of student engagement, with

knowledgeable and caring staff guiding that work," he said.

Most importantly, he believes that all adults must be committed to connecting meaningfully with even the most challenging learners.

"Our work is about connections," he said. "It is imperative that we create an environment where students are energized by both the content they are learning and by the adults who are guiding that work."

Mr. Adams holds a master's degree in English education from SUNY Buffalo and bachelor's in history from SUNY Geneseo. He is also certified as a NYS school district administrator.

Mr. Adams succeeds Jennifer Barker, who became the district's Director of Pupil Services.

"We are always striving to be the best we can be, but don't stop to think how great we are actually doing. As High School students, we don't give ourselves enough credit."


Olivia said the best thing about being a student at Hamburg is the support network that surrounds students.

# Free & reduced price school meals

Dear Parent/Guardian:

Children need healthy meals to learn. Hamburg Central Schools offer healthy breakfasts and lunches every school day! Full price meals: *Elementary* breakfast-\$1.75, lunch-\$2.35; *Middle School* breakfast-\$2.00, lunch-\$2.60; *High School* breakfast-\$2.00, lunch-\$2.85. Your children may qualify for free meals or for reduced price meals. \*\*\*Beginning July 1, 2019, students in New York State that are approved for reduced price meals will receive breakfast and lunch meals at no charge.

Each new school year an application needs to be filled out and returned by the end of September. June's eligibility carries forward into the new school year; however, we must receive a new application by October 1<sup>st</sup> to ensure processing before the grace period expires. Failure to do so will revert students to full price. *Please return the application or submit an electronic application online at MySchoolApps.com as soon as possible.* Refer to the *Application Fact Sheet* on our website, www.HamburgChildNutrition.com, or call Anne Rich at 716-646-3250 ext. 5005 for assistance in filling out the application.

Results from the application/direct certification process are tabulated and used to determine District funding for other student programs. <u>In order to maximize funding for</u> <u>the students of Hamburg, we must maximize the number of family applications. Applications and their outcomes are kept confidential</u>. Parents need to return a signed consent form for individual eligibility status to be shared. Consent forms are available on the Food Service page of the District Website.

- DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Complete the application to apply for free or reduced price meals. Use one Free and Reduced Price School Meals Application for all students in your household. We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to: to Hamburg Food and Nutrition Services, 360 Division St., Hamburg 14075 or file electronically at MySchoolApps.com
- 2. WHO CAN GET FREE MEALS? All children in households receiving benefits from SNAP, the Food Distribution Program on Indian Reservations or TANF, can get free meals regardless of your income. Categorical eligibility for free meal benefits is extended to all children in a household when the application lists an Assistance Program's case number for any household member. Also, your children can get free meals if your household's gross income is within the free limits on the Federal Income Eligibility Guidelines. Households with children who are categorically eligible through an Other Source Categorically Eligible designation, as defined by law, may be eligible for free benefits and should contact the SFA for assistance in receiving benefits.
- 3. CAN FOSTER CHILDREN GET FREE MEALS? Yes, foster children that are under the legal responsibility of a foster care agency or court, are eligible for free meals. Any foster child in the household is eligible for free meals regardless of income. Foster children may also be included as a member of the foster family if the foster family chooses to also apply for benefits for other children. Including children in foster care as household members may help other children in the household qualify for benefits. If non-foster children in a foster family are not eligible for free or reduced price meal benefits, an eligible foster child will still receive free benefits.
- 4. CAN HOMELESS, RUNAWAY, AND MIGRANT CHILDREN GET FREE MEALS? Yes, children who meet the definition of homeless, runaway, or migrant qualify for free meals. If you haven't been told your children will get free meals, please call or e-mail Colleen Kaney, Asst. Supt. of Student Services, at 646-3200 ext. 7210; ckaney@hamburgschools.org to see if they qualify.
- 5. WHO CAN GET REDUCED PRICE MEALS? Your children may be approved as reduced price eligible if your household income is within the reduced-price limits on the Federal Eligibility Income Chart, shown on this letter. Beginning July 1, 2019, students in New York State that are approved for reduced price meals will receive breakfast and lunch meals at no charge. (But you MUST apply)
- 6. SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE APPROVED FOR FREE MEALS? Please read the letter you got carefully and follow the instructions. Call the food Service office at 716-646-3250 ext. 5005 with questions.
- MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT ANOTHER ONE? Yes. Your child's application is only good for that school year and for up to the first 30 operating days of this school year. You must send in a new application unless the school notified you that your child is directly certified for free meals before school starts.
- 8. I GET WIC. CAN MY CHILD(REN) GET FREE MEALS? Children in households participating in WIC may be eligible for free or reduced price meals. Please fill out a FREE/REDUCED PRICE MEAL application.
- 9. WILL THE INFORMATION I GIVE BE CHECKED? Yes and we may also ask you to send written proof.
- 10. IF I DON'T QUALIFY NOW, MAY I APPLY LATER? Yes, you may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced price meals if the household income drops below the income limit.
- 11. WHAT IF I DISAGREE WITH THE SCHOOL'S DECISION ABOUT MY APPLICATION? You should call the Food Service Director first. If needed, you also may ask for a hearing by calling or writing to: Barbara Sporyz, Asst. Supt. of Admin Services & Finances, 5305 Abbott Rd, Hamburg, NY 14075; 716-646 3200 ext. 7214.
- 12. MAY I APPLY IF SOMEONE IN MY HOUSEHOLD IS NOT A U.S. CITIZEN? Yes. You or your child(ren) do not have to be U.S. citizens to qualify for free or reduced price meals.
- 13. WHO SHOULD I INCLUDE AS MEMBERS OF MY HOUSEHOLD? You must include all people living in your household, related or not (such as grandparents, other relatives, or friends) who share income and expenses. You must include yourself and all children living with you. If you live with other people who are economically independent (for example, people who you do not support, who do not share income with you or your children, and who pay a pro-rated share of expenses), do not include them.
- 14. WHAT IF MY INCOME IS NOT ALWAYS THE SAME? List the amount that you normally receive. For example, if you normally make \$1000 each month, but you missed some work last month and only made \$900, put down that you made \$1000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.

How to Apply: To get free or reduced price meals for your children carefully complete one application following the instructions for your household and return it to the designated office listed on the application. If you now receive SNAP, Temporary Assistance to Needy Families (TANF) for any children or participate in the Food Distribution Program on Indian Reservations (FDPIR), the application must include the children's names, the household SNAP, TANF or FDPIR case number and the signature of an adult household member. All children should be listed on the same application.
