# Welcome to the Coaching Certification Process in the Hamburg Central School District!

In order to be <u>a head coach</u>, <u>assistant coach</u>, or <u>volunteer coach</u> in New York State, there are several requirements that must be fulfilled. Individuals are responsible for completing these requirements, completing the courses and certifications, paying the fees, supplying the district with copies of all completed certifications and reporting their progress.

The following steps are for those coaches NOT holding a valid NYS teacher or pupil personnel certification.

### How to complete the requirements:

# 1. Fingerprinting (See details in Attachment A)

The cost for fingerprints is approximately \$102.00.

## INITIAL TEMPORARY LICENSE requirements will include:

- a. Valid First Aid (Certification must match a title from the approved course list)
- b. Valid CPR/AED (Certification must match a title from the approved course list)
- c. Workshop: School Violence (SAVE)
- d. Workshop: Child Abuse
- e. Workshop: Dignity for All Students Act (DASA)
- f. Fingerprint Clearance as referred to in #1
- g. District Statement of Recommendation (supplied by Hamburg Schools directly to TEACH)
- h. Application fee of \$50 due when applying for license

Steps for yearly renewal of coaching license.

1<sup>ST</sup> RENEWAL OF TEMPORARY LICENSE will include same as above.

2<sup>nd</sup>-4<sup>th</sup> RENEWAL OF TEMPORARY LICENSE</sup> includes the same as above AND Coursework -see below PROFESSIONAL COACHING LICENSE includes the same as above AND the following:

- a. Minimum 3 prior temporary coaching licenses
- b. Satisfactory Evaluation, sport specific, by athletic director or principal for each year of 3 temporary coaching licenses held
- c. Completion of all coursework (Option 1 or Option 2)

# COURSES ACCEPTED AS MEETING THE COACHES' FIRST AID REQUIREMENT **Revised April 2023**

FIRST AID - All cards and/or certificates must be renewed per certifying agency requirements. COMPLETELY ONLINE COURSES ARE NOT ACCEPTED. ALL COURSES MUST INCLUDE HANDS ON LEARNING.

Please note: Review courses are only accepted with proof of taking initial course. Participant must possess a current certificate(s) (or equivalent) in order to take a review course. Challenge courses are not accepted by NYSED.

\*Individuals holding a NYS PROFESSIONAL LICENSE issued by the Office of the Professions in any of the medical fields identified below can meet the NYS First Aid requirement by submitting verification of their license registration and provide either a current letter of employment or verification of any current first aid course. They will also need to submit a valid CPR/AED certificate for their coaching license application. a. All Nurses (RN, LPN, NP), b. Physician - Physician Assistant (MD, DO), c. Certified Athletic Trainer (ATC), d. Dentists (Includes Oral and Maxillofacial Surgeons), e. Physical Therapists, f. Optometrists
